Naber and her heirs and assigns all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the First Ward of the City of Greenville having the following lines and bounds according to a survey made during the present month by W. C. Dalton, surveyor to wit: Beginning at an iron pipe on the north-west side of Atwood Street, corner of W. J. Hunt property, thence along the north-west side of Atwood Street 44' 3" 22' C. seventy-one and several tenths (71.7) feet to a stake two (2) inches south of a stone pier, corner of John H. Williams property, thence along line of said property N. 42° 48' W. one hundred and eighty and two-tenths (180.2) feet to the south end of a concrete wall, thence along east line along property of Edw. Lewis S. 48° 34' W. sixty-nine and several tenths (69.7) feet to an iron pipe, corner of W. J. Hunt property thence along line of said property S. 42° 50' C. one hundred and forty nine (149) feet to the iron pipe on Atwood Street at the beginning corner.
