has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Arnold W. Earle

all those two certain lots of land situate and bounded as follows: Acre or a short distance from Augusta Road in the County and State aforesaid, known and designated as Lots 77 and 78 of Trappel Park as shown on platted thereof made by R. C. Dalton and recorded in R. M. C. Office for Greenville County in plat book C, page 270, said two lots together having the following interval bounds, to wit: Beginning at a stake on the south side of said Avenue, corner of lot 76 and running thence with line of lot 76, S. 25-22 E. 286.4 ft. thence with line of lot 76, S. 50-29 W. 100.9 ft. thence with line of lot 78, S. 64-38 W. 100 ft. thence with line of lot 81, N. 20-22 E. 300 ft. to said Avenue, thence with said Avenue S. 64-38 E. 200 ft. to the beginning corner.

Subject, however, to the following restrictions which are parts of the consideration for this deed and are made for the benefit and protection of the other lots above on the plat aforesaid to and are hereby declared conditions subsequent.

(1) This property, nor any part thereof, shall not be sold, rented nor otherwise disposed of to any person of a vicious decent.

(2) No building costing less than Sixty - Five hundred

(1500.00) Dollars shall be erected upon said property other than out buildings appertaining to a dwelling.
