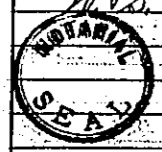

All that certain lot or parcel of land, situate, lying and being near the City of Greenville, Greenville Township, County and State aforesaid, and being better known and designated as lot No. 103 of Traveled Park subdivision of the Realty Corporation and shown on a plat made by P.E. Dalton, Engineer, March 1923, and having according to said plat, the following meter and bounds to wit: Beginning at an iron pin on the east side of Augusta Road, joint corner of lots 102 and 103; thence with the joint line of said lots N. 60.46 E. 206.8 feet to an iron pin; thence S. 53.56 E. 71.3 feet to another iron pin, joint corner of lots No. 103 and 104, thence with the joint line of said lots S. 58.24 W. 234 feet to an iron pin on the Eastern side of Augusta Road, thence with said Augusta Road N. 28.17 W. 76 feet to the point of beginning.

- (1) No Residence shall be erected upon said lot costing less than Seventy Five Hundred (\$7500.00) Dollars, nor nearer to Augusta Road than fifty (50) feet. (2) The property herein conveyed, nor any part thereof, shall never be sold, rented or otherwise disposed of to persons of African descent. (3) The land herein conveyed shall be used only for residential purposes and nothing shall be placed thereon which would constitute a nuisance or damage the adjoining lots or in any way make them undesirable for residential purposes.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and his heirs and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof.
