to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto W. B. McGowan,

his heir and assigns All that certain lot of land in Block Five (5) of the City of Greenville, East of River Street, on South side of Bagle Street and designated as lot No. 3 of the E. G. Mallard property as appears by plat of same recorded in the Office of the P. M. C. for Greenville County as Plat Book 16 at page 57, and more particularly described as follows:

Beginning on Bagle Street at a point 40 feet from small street fronting on Bagle Street 40 feet and running 40 feet in parallel lines to center of S. W. C. Spine Track. Together with all right title and interest to hold and use thereof to the building situate on lot No. 2, together with all right title and interest of an in the Industrial Spur Track of the C. W. C. Railroad, situate in the rear of the aforesaid property.

As a part of the consideration for the foregoing premises the grantee herein agreed to assume the payment of a note and mortgage on the within described premises in the sum of \$4000.00 executed by E.
