heirs and assigns forever, the following described real estate: All that certain lot of land situated lying and being near the corporate limits of the City of Greenville County and State aforesaid and on the south side of the Laurens Road and being known and designated as Lot No. 27 of "Glenn Grove Park" as shown by a subdivision and plat of same made by A. E. Dalton, Engineer, in May 1924 said plat being of record in the R. M. Co. Office for Greenville County in Plat Book 3 at page 233 and having the following metes and bounds and courses and distances, to wit:

Beginning at an iron pin on the south side of the Laurens Road at the joint corner of Lots 24 and 25, and running thence along the line of Lot No. 28 S. 15.48 W. 160.1 feet to a point in line of Lot No. 30, thence along the line of Lot No. 30, S. 74.12 E. 50 feet to corner of Lots 23 and 26, thence along the line of Lot No. 26 N. 15.48 E. 159 feet to iron pin in line of Laurens Road, thence along said road N. 37 W. 50 feet to the beginning corner and lying a part of the land conveyed to the Home Builders Company by Mollie J.
