Parties of the first part agree hereby to lease unto party of the second part, for a period of one year, beginning October 9th, 1922 and ending October 9th, 1923, at a monthly rental of One liundred Dollars per month, payable on the first day of each month, the following described premises:

All the ground floor, known as the "Banking Room" in that two story building located in the State and County aforesaid, in the Town of Greer, at the intersection of Trade and Randall Streets, being on South side of said Randall Street and on the East side of said Trade Street; giving said party of the second part the option of renewing this contract and lease for an additional period of five years from October 9th, 1923, at a rental to be agreed upon by parties of the first part and by the Board of Directors of said party of the second part.

Party of the second part agrees, hereby, through its proper officers whose signatures are hereto subscribed, to pay the rental as hereinabove named, and agrees in like manner to comply with all reasonable customs governing the occupancy of buildings by tenants.

It is further agreed by the parties hereto that parties of the first part are to furnish lights, water, heat and janitor service in the above described premises and that the charges for these are included in the above mentioned rental of One Hundred Dollars per month.
