Stella Cothran.

Whereas, We, Lee Alexander and Beler Alexander, his wife of the County and State aforesaid, being in such financial straits that we are unable to properly care for, support and rear our minor child, Mary Jane Alexander, aged two years, and are anxious to make proper provision for her and to have her properly reared, trained and cared for; and

Whereas, we have and repose special confidence in Ars. Stella Cothran, of the said State and County, the mother of the said Lee Alexander, who has agreed to take, train and properly provide for our said daughter, to furnish her with proper food and clothing, and with medicine and medical attention if she shouls ever need same; and

Whereas, the said Stella Cothran imposes the condition precedent that she must have the entire custody and control of our said daughter and be entitled to her service until she shall become twenty-one years of age, to which we have agreed:

Now know all men by these presents, in consideration of the premises and circumstances above set forth and in further consideration of the sum of three dollars to us in hand paid, the receipt whereof is hereby acknowledged, we, Lee Alexander and Beler Alexander, have granted, bargained and conveyed, and by these presents do grant, bargain and convey unto the said Stella Cothran the custody and control of our said daughter dary Jane Alexander until October 11, 1942, on which date she will be twenty-one years of age:

To have and to hold the sole and complete custody, control, parental authority and right to the services of the said Hary Jane Alexander, to her the said Stella Cothran and her heirs, executors and administrators until October 11, 1942.

It is expressly agreed that if for any reason the said Mary Jane Alexander shall leave the custody of said Stella Cothran, said Stella Cothran is, if she so elects, released from all liability arising out of this agreement relating to the said Mary Jane Alexander; and we do hereby bind ourselves, our heirs, executors and administrators to warrant and forever defend the custody and control of said Mary Jane Alexander unto the said Stella Cothran against all persons whom soever claiming or to claim the same. This deed is intended to comply with the Statutory Law of this State in regard to the disposition of the custody, control and services of minors, and all or any formal defect or other defects are hereby waived.
