One, Two, Three, Five and Four (1, 2, 3, 5, 4), excepting and reserving a certain lot hereto fore conveyed to the Trustees of Pleasant Crove School, containing One (1) acre, more or less, and also a lot of One (1) acre, heretofore conveyed to J.N.
