To Have and to Hold all and singular the Premises before mentioned unto the said Mill's Mill and its successors, and Assignee forever.

And the said Farmers Loan and Trust Company does hereby bind itself, and its successors, to warrant and forever defend all and singular the said Premises unto the said Mill's Mill, and its successors and assigns, against itself and its successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
