Beginning on the north east corner of Simpsonville  
Guard House Board running North along side Wall 18 1/4  
feet to an iron pin 30 inches in an Westerly direction  
42 feet two inches to an iron pin thence in an South  
East direction 20 feet to an iron pin thence in an Easternly  
direction 33 feet and three inches along said Guard  
House as a line to the Beginning corner.
