from Greenville County Court House, and on Wright and Church Streets
and having the following meters and bounds according to a plat

Beginning at an iron pin on Church Street corner of lot #44
and running thence in a southwesterly direction across lot #44, 197
feet to an iron pin on Wright Street, thence along Wright Street
#1-21-09 W. 149 feet to a stake in line of lot #61, thence along line
of lots 6 and 7, N. 33-51 E. 109 feet, more or less, to a stake in
line of lot 29, thence along line of lot 29, S. 47-26 E. 66-2 feet
