Office for said County in Plat Book "F" at pp. 66 - 67. The said lot has the following metes and bounds: Beginning at a stake at the northeast corner of the said Streets and running thence along Oregon Street N. 65-30 E. sixty feet to a stake, corner of Lot #2; thence along said lot N. 26-30 W. one hundred and sixty-five feet to a stake, corner of lot #9; thence along said lot S. 63-30 W. sixty feet to a stake on Mitchell Street; thence along said Street S. 26-30 E. one hundred and sixty-five feet to the beginning point.
