(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Nan Sloan: All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and situated on the north side of Oregon Street, and known as Lot #3 in Block "D" on plat of the said property recorded in R.M.C. Office for said County in Plat Book "F", at pp. 66 - 67.

The said lot has the following metes and bounds: beginning at a stake on the north side of Oregon Street, at corner of Lot #2, in said Block, heretofore sold to S.M. Lawton and running thence along said Street, N. 63-30 E. sixty feet to stake corner of lot #4; thence along said lot N. 26-30 W. one hundred and sixty-five feet to stake corner of lot #11; thence along said lot S. 63-30 W. sixty feet to stake corner of lot #2; thence along said lot S. 26-30 E. one hundred and sixty-five feet to the beginning point on Oregon Street.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named Nan Sloan, her heirs and assigns, all the land herein described from the lien of two mortgages executed by F.A. Lawton, dated Nov. 17, 1920 and May 6, 1922, and recorded in Volume #33, one at page 186 being given to secure a note in the sum of twenty thousand dollars and one at page 216 to secure a note in the sum of ten thousand dollars.
