(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

C.L. Bolt: All those three certain pieces, parcels or lots of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and known as lots #19, #20 and #21, in Block "F" on revised plat of the said property to be recorded in R.M.C. Office for said County.

The said lots have the following metes and bounds: beginning at a stake on the south side of Blassingame Street, corner of lot #18, and running thence along the said Street, 180 feet to stake at corner of Lot #22; thence along said lot, 160 feet to stake at corner of lot #7; thence along lots #7, #6 and #5, to stake at corner of lot #18; thence along said lot, 160 feet, more or less, to the beginning point on Blassingame Street.
