 Lillie K. Elrod - All that certain lot or parcel of land
 situate, lying and being in Greenville Township, County and
 State aforesaid, on the Paris Mountain Road, near the City of
 Greenville known and designated as Lot No. 58, as shown
 on a plat of the Perry Estate of record in the R.M.C. office
 for Greenville County, South Carolina, in Plat Book "G" page
 127, and having according to said plat, the following metes
 and bounds, etc. wt:

Beginning at an iron pin on Paris Mt. Road joint
 corner of Lots 58 and 59 and running thence with the
 Paris Mountain Road N. 16-17 W. 77.7 feet to an iron pin
 corner of Paris Mountain Road and Marlin Street, thence
 with Marlin St. S. 58-30 W. 220.5 feet to an iron stake
 joint corner of lots 58 and 57, thence S. 31-30 E. 75 feet
 to an iron pin thence along line of lot No. 59, N. 58-30 E.
 200.2 feet to the beginning corner.

 rented, or otherwise disposed of to Negroes or persons
 having any percentage of Negro blood.
