(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said D.P. Bates, his heirs and assigns, all those two certain pieces, parcels or tracts of land situate, lying and being in the State of South Carolina and County of Greenville, in Bates Township, in the village of Marietta, having respectively the following metes and bounds, according to a plat thereof made by W.A. Hester, dated August 29, 1923, to-wit:-

First: That lot beginning at an iron pin on west side of Cleveland Avenue on the original southern boundary line of the Cleveland land (this being on the northern boundary line of a lot conveyed to the said D.P. Bates by I.S. Eppes, and running thence along said Cleveland Avenue N. 23° E. 24 links to an iron pin on said Cleveland Avenue, on the south-east corner of a lot conveyed to the said D.P. Bates by I.S. Eppes; thence along line of the last mentioned lot in the rear thereof, belonging to said grantors N. 67° W. 6.70 chains to an iron pin; thence along line of other lands belonging to said grantors S. 23° W. 2.50 chains to an iron pin on line of the first lot hereinabove referred to as conveyed to the said D.P. Bates by I.S. Eppes; thence along line of said lot S. 86° E. 6.96 chains to the beginning corner, containing nine-tenths (9/10) of an acre, more or less.

Second: That lot lying north and west of the lot first above described, beginning at an iron pin on the east side of Beaverdam Creek, on the original south boundary line of the Cleveland land and on the north boundary line of lot first above mentioned as conveyed to the said D.P. Bates by the said I.S. Eppes, and running thence along line of said lot S. 86° E. 8.70 chains to an iron pin; thence along line of other land belonging to said grantors N. 23° E. 3.90 chains to an iron pin; thence S. 67° E. 2.30 chains to an iron pin; thence along line of other land belonging to said grantors N. 23° E. 3.19 chains to an iron pin; thence S. 67° E. 25 links to a stone on corner of land conveyed to the said D.P. Bates by A.J. Bishop; thence along line of last mentioned lot N. 23° E. 3.54 chs. to a stone; thence still along line of last mentioned lot S. 67° E. 6.50 chs. to an iron pin on the west side of Cleveland Avenue; thence along said Avenue N. 23° E. 3.17 chs. to an iron pin on line of other lands belonging to said grantors; thence along line of such lands N. 67° W. 2.28 chs. to an iron pin; thence N. 23° E. 1.50 chs. to an iron pin; thence N. 67° W. 4 chs. to a maple tree; thence (still along line of other lands of grantors) S. 83° W. 21.20 approximately S. 22° E. 6.76 chs. and S. 10° E. 3.90 chs. to the beginning corner, containing nineteen-and-three-quarter (19 3/4) acres, more or less.

This is a part of tract No. 1 of the old family homestead of J. Harvey Cleveland, deceased, as shown by plat of William A. Hudson, dated January 6, 1893, and recorded in the office of the Register of Deeds Conveyances for said County and State in Plat Book "B", at page 269. It descended to his widow and children and said children conveyed their interest therein to their mother, Mrs. Mary L. Cleveland, by deed dated January 14, 1893, and recorded in said office in Deed Book "Z", at page 106.

Upon the death of the said Mary L. Cleveland her other children conveyed their interest therein to R.Mays-Cleveland by deed dated May 16, 1896, and recorded in said office in Book "CCC", at page 260. Said R.Mays Cleveland devised said land to his only two children, the grantors herein, by his will dated January 29, 1897, admitted to probate by the Probate Court for said County and State on September 25, 1916, and now on file in the office of said Court in Apartment 135, File 21.

For value, I hereby release unto D.P. Bates, his heirs and assigns so much of the land as is within described from the lien of a mortgage given me by the within grantors, for \$7500.00, said mortgage recorded Vol. 95, Page 83.
