All that piece, parcel or lot of land in Greenville Parish, City of Greenville and Greenville County, State of South Carolina, situate on the South side of Madison Street in Ward Three of the City of Greenville and described as follows: Beginning at an iron pin on the South side of Madison Street and running thence along said Street S. 43 N. 66 feet 8 inches to an iron pin thence in a Southeastern direction 57 feet 9 inches to an iron pin; thence N. 41 E. 67 feet to a locust tree; thence W. 48 N. 57 feet of inches to the beginning corner, and being the same lot of land conveyed to me by C. P. Simmons by his deed dated the 29th day of June, 1922, which deed is recorded in the R. M. C. Office for Greenville County in Deed book 84 of Deeds page 46 or in book 83, page 21, recorded July 4th, 1923.

All that certain piece, parcel and lot of land situate lying and being in the County and State aforesaid and in Ward Three of the City of Greenville, lying immediately in rear of the lot of land hereinabove described and being more particularly described as follows: Beginning at a stake in line of Hartwell, 150 feet South of West Washington Street, and running thence along Hartwell line in a Southernly direction 67 1/2 feet to an iron pin; thence in a Westernly direction parallel with West Washington Street 75 feet to an iron pin; thence in a Northernly direction along rear line of the lot above described 67 1/2 feet to the corner; thence in an Easternly direction 75 feet to the beginning corner, and being the same lot of land conveyed to me by C. P. Simmons by his deed dated June 29th, 1922, which deed is recorded in the R. M. C. Office for Greenville County in Deed book 83 page 21.
