at and before the sealing of these presents by Greenville Realty & Investment Company

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the
Greenville Realty & Investment Company, its successors and assigns forever: All that certain
lot or parcel of land in the County and State aforesaid, lying and being situate in Ward 3,
upon the South side of West Broad Street in the City of Greenville, and having the following
metes and bounds, to-wit:

Beginning at an iron pin on said Broad Street 55 feet Eastward from the Southeast corner of
Broad and Jackson Streets, and running thence S. 17-30 W. (parallel with Jackson Street) 100
feet to an alley; thence along the north side of said alley S. 72-30 E. (parallel with Broad
Street) 45 feet to stake on said Alley; thence N. 17-30 E. (parallel with Jackson Street) 100
feet to a stake on the south side of Broad Street; thence N. 72-30 W. along said Street to
the beginning corner; save, however, to the reservations as to the walls and the use thereof
as contained in the deed to the above premises to J.P. Ables by C.C. Hindman, said deed recorded

As a part of the consideration for this conveyance, the grantee by acceptance of this deed,
assumes and agrees to pay two certain mortgages with interest thereon from the date of this
conveyance, as follows:

One certain mortgage executed by J.W. Kirkpatrick to Shenandoah Life Insurance Company in the
sum of Twelve thousand, five hundred dollars (\$12,500.00) dated April 26th, 1923, due and
payable three (3) years after date, with interest at the rate of six (6) per cent. per annum,
payable semi-annually, said mortgage being recorded in the R.M.C. Office for Greenville County
in Vol. 130, at page 5.

Also: One certain mortgage executed by J.W. Kirkpatrick to J.L. Love, in the sum of Six
hundred Dollars (\$600.00) dated April 26th, 1923, due and payable six (6) months after date,
with interest at the rate of eight (8) per cent. per annum payable annually, said mortgage
being recorded in the R.M.C. Office for Greenville County in Vol. 129, at page 272.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or
appertaining.
