piece parcel or set of land in Greenville Township near  
the City of Greenville, Greenville County, State of South  
Carolina, in the subdivision known as "Kananaski" and  
situated on the north side of Oregon Street and known  
as lot no. 4 of Block "B" on plat of the said property  
recorded in Office of R. M. C. for Greenville County in Plat  
Book "D" at page 66-67 and having the following metes  
and bounds to-wit:

Beginning at a stake on the north side of Oregon Street  
at the corner of lot no. 3, now or formerly owned by

63-30 E. Sixty feet to a stake at corner of lot no. 5
