at and before the sealing of these presents by W.K. Livingston, as Trustee

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Parcel One: All that piece, parcel or tract of land containing 1-4/100 acres, more or less, situate, lying and being in the County and State aforesaid, on the South side of the Augusta Road, near the Southern limits of the City of Greenville, and having the following metes, courses and distances, to-wit:
Beginning at an iron pin 3x on Augusta Street and corner of a new street, and running thence along the west side of said new Street S. 26-1/2 W. 13.40 chains to an iron pin 3x on; thence N. 33-3/4 E. 12.85 chains to an iron pin 3x on said Augusta Street; thence along the south side of said Street N. 46 W. 1.59 chains to the beginning corner, the same being a part of tract No. 2 of the sub-division of the said Birnie land.

Parcel Two: All that piece, parcel or lot of land situate in the County of Greenville, South Carolina, near the Southern limits of the City of Greenville, on the South side of the Augusta Road, containing five (5) acres, more or less; Beginning at an iron pin 3x on corner of Lot No. 1 of the Birnie Lands on the Augusta Road; thence along the south side of said Road N. 46 W. 3.17 to an iron pin 3x on; thence S. 33-3/4 W. 12.85 to an iron pin 3x on; thence S. 66-3/4 E. 5.25 to an iron pin 3x on line of Lot No. 1; thence N. 23-1/2 E. 11.55 to an iron pin 3x on on the Augusta Road, the beginning corner, being the northern portion of lot No. 2 of the Birnie Land as shown by plat of J.N. Southern, Surveyor, April 21, 1893.

Parcel Three: All that strip of land in Greenville County, South Carolina, being about five (5) feet in width, and running from Augusta Road until it reaches Lewis' line where conveyed to said Lewis; said strip of land lies between land of Mrs. Cary (the John C. Cary Home Place) and Conestee Avenue, with the right to the use of Conestee Avenue as a street by the grantee, his heirs and assigns.

TOGETHER with, all and singular, the rights, members, hereditaments, and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said W.K. Livingston, as Trustee, his Successors

heirs and assigns, forever. In trust, nevertheless, to hold said lands, make such improvements as he may deem advisable, and convey the land as a whole or in parcels upon such terms as he may deem advisable, and after paying taxes and all expenses incurred in improving and selling said property, to apply the proceeds of sale to the payment of the amount advanced by J.K. Livingston to pay all encumbrances over said lands, to-wit, \$55,500.00, and interest thereon from December 20, 1923, at the rate of 7% per annum, payable semi-annually, until principal and interest are paid in full and then to turn over to Mary L. Cary any moneys remaining, or to, at her written request, convey to her or such person as she may designate, any lands remaining unsold. The purchaser or purchasers of said land not to be bound to see to the application of the purchase money or any part thereof.

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
