containing twenty four and one half (24 1/2) acres more or less and to herein as tract No. 3, in the division of the lands aforesaid. Bounded by tract No. 2, and having the following metes and bounds: Beginning on corner of No. 2 tract thence N. 85° E. 14.50 to stake #50 n. thence N. 50° E. 28.80 to a stone x 3 ons; thence N. 83 W. 5.50 to a stake x 2 m. m. thence S. 22 1/4 E. 28.00 to the beginning and is more fully represented and described by a plat made by Tom F. Lee Surveyor, March 6, 1923 reference thereto being had will more fully appear.
