I, E. Inman
Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, G. D. Charles

on or about the 21st day of February in the year of our Lord nineteen hundred and twenty three exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against P. F. Dickson, et al,

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 14th day of June 1923, and such proceedings were had therein as resulted in a decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described be sold by E. Inman Master in and for the County aforesaid, of the terms and for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; and the Master, after having duly advertised the said real estate

NOW, Therefore, Know all Men by these Presents, That I, E. Inman Master in and for the County of Greenville, aforesaid, in consideration of the sum of Forty Two Hundred (\$4200.00) Dollars, to me paid by the said G. D. Charles

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

J. D. Charles and his heirs and assigns forever, the following described real estate:
"All that piece, parcel or lot of land in Grove Township, County and State aforesaid about nine miles from Greenville Court House on the road leading from Log Shoals Road to Cavester Mills, having the following metes and bounds, Beginning at maple (gone) 30 on west bank of Reedy River and running thence S. 72 3/4 W. 11.60 to iron pin; thence S. 21 W. 13.50 to iron pin on road; thence with said road N. 5 W. 4.36 to iron pin; thence S. 74 1/2 W. 1.61 to poplar on branch; thence S. 73 1/2 W. 8.33 to iron pin; thence N. 27 W. 17.52 to iron pin on J. M. Riddle's land; thence N. 54 E. 42.96 to maple (gone) on Reedy River; thence down meandering of said river to the beginning, corner containing Sixty-seven and 1/100 acres (or less) more or less.
