D. Isbell (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. D. Isbell

All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as lot No. 10, and part of lot No. 11, of the subdivision known as Augusta Circle as shown on a plat of record in the R. M. C. Office for Greenville County, South Carolina, in the Plat Book "F," page 23, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of West Augusta Drive, which iron pin is 100 feet eastward from the northeast corner of said Drive and Faria Road, and is the joint corner of lots Nos. 9 and 10 and running thence with the joint line of said lots N. 20-14 E. 160 feet to an iron pin in line of lot No. 7; thence S. 55-13 E. 62-1/2 feet to an iron pin in joint line of lots Nos. 11 and 6, which iron pin is 162 1/2 feet eastward from Faria Road; thence S. 20-16 W. 160 feet to an iron pin on the northern side of West Augusta Drive, which iron pin is 162 1/2 feet from the northeast corner of said Drive and Faria road, thence along the northern side of said West Augusta Drive N. 55-13 E. 62 1/2 feet to the point of beginning. Being all of western side of lot No. 11.

- (1) No buildings shall be erected nearer to the abutting sidewalk than twenty feet, except on lots Nos. 23 to 39, inclusive.
(2) The facing of the lots as shown on said plat shall be strictly adhered to, however more than one lot may be used for the purpose of erecting a dwelling.
(3) The property herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons having any percentage of negro blood.

And I do hereby bind myself as Trustee, and my successors in office to warrant and forever defend all and singular the said premises unto the said J. D. Isbell, his Heirs and Assigns, against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
