TITLE TO REAL ESTATE.

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said D. D. Smith all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

All that certain Tract of Land situate in the County and State aforesaid about two and one-half miles from the Court House in Greenville and having the following dimensions and bounds to-wit:

Beginning at an iron fence corner of D. D. Smith's tract, on Smith St. running N. 64-20 E. two hundred feet along Mount Vista Ave. to an iron fence thence N. 25-40 E. two hundred feet to iron iron fence, thence S. 64-20 W. two hundred feet to iron fence, thence S. 25-40 E. two hundred feet along Smith St. to the beginning corner, being designated as Lot 12, in the Plan of lots of D. D. Smith made by C. J. F. Johnson, on March 5th 1923 and recorded in R. 911 C. Office of Greenville County in Book T page 108.
