Floyd: All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina: Beginning at an iron pin on Thompson Road at corner of tract No. 2 of the J.E. Beattie estate and running thence N. 65-0 E. 1365' to an iron pin, joint corners of tracts Nos. 2 and 3 of said Estate; thence with line of tract No. 3, S. 80-15 E. 157' to point on said line; thence S. 43-15 W. 785' to iron pin; thence S. 65-10 W. 908' to iron pin on Thompson Road; thence along said Thompson Road N. 37-50 W. 238' to a point on said road; thence N. 10-5 W. 164' to iron pin on said road the beginning corner, containing Fourteen (14) acres, and being a part of tract No. 1 of survey of J.E.
