KNOW ALL MEN BY THESE PRESENTS, That I, Lane A. Bradley

in the State aforesaid,

in consideration of the sum of One (\$1.00) Dollar

to M.R. in hand paid at and before the sealing of these presents by C.W. Greenway

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said C.W. Greenway: All that lot of land lying in the County of Greenville, State of South Carolina, about One and one-half miles Northwest of the County Court House, on Hammett Street, and East of the Main line of Southern Railway and having the following metes and bounds: Beginning at an iron pin on Hammett Street at the Northwest corner of Lot No. 20 (As shown on a plat of the Hammett lands, surveyed by W.A. Hudson, dated November 15th, 1897, said plat being recorded in the R.M.C. Office of Greenville County in book "HHH", pages 836 and 837) and running thence parallel with Hammett Street, West (N. 68-3/4 E.) 100 feet to an iron pin; thence South (21-1/2 W.) 242 feet to an iron pin; thence North (21-1/2 E.) 254 feet to an iron pin at the beginning corner. The above being a part of the original lot conveyed to me by D.J. Hammett and Jas. L. Orr, Executors, by deed dated August 19th, 1901 and recorded in the R.M.C. Office of Greenville County in Book "III", page 386 (the other portion of this lot No. 19 was previously conveyed by me to F.W. Poe Mfg. Co. by deed dated March 10th, 1902 and recorded in the R.M.C. Office of Greenville County in book "III", page 613).

Also: All that lot of land lying in the County of Greenville, State of South Carolina and adjoining the above described lot on the West side and having the following metes and bounds: Beginning at an iron pin on Hammett Street at the northwest corner of lot No. 19 (As shown on the above described plat) and running thence parallel with Hammett Street West (68-3/4 E.) 100 feet to an iron pin at the Northeast corner of lot No. 17; thence South (21-1/2 E.) 219 feet and 9 inches to an iron pin; thence East (- - -) 101 feet and 6 inches to an iron pin; thence North (21-1/2 W.) 236 feet 8 inches to an iron pin at the beginning corner. The above being the same lot of land conveyed to me by F.W. Poe Mfg. Co. by deed dated March 6th, 1902, and recorded in the R.M.C. office of Greenville County in Book 105, at page No. 287.

This deed is made for the purpose of correcting a deed previously made by me to the said C.W. Greenway dated March 27th, 1920 and recorded in the R.M.C. Office for Greenville County in Volume 63, page 382; said deed included a lot which had been previously conveyed by me to F.W. Poe Mfg. Co. and did not include the second lot therein described, whereas said deed was intended to include only the lots which are herein described. The above change made with the consent of, and in the presence of all signers of this paper, and before same was signed.
