Know all men by these presents, That Miss Sallie H. Harris, Mrs. Edna E. Willis, F.M. Harris, Mrs. Mary H. Willis, Mrs. Susan H. Pilcher and Mrs. Nona H. Squires of said County and State, in consideration of the premises, and of the sum of One Dollar to them in hand paid by the Southern Power Company, the receipt whereof is hereby acknowledged, do hereby grant unto the said Southern Power Company, its successors and assigns, the right, privilege and easement to go in and upon the tract of land, situated in said County and State, bounded by lands of Starkey and Murry, T.F. Hunt, M.P. Hall & others, and to construct and maintain in, upon and through said premises, in a proper manner, with poles, towers, wires, and other necessary apparatus and appliances, a lien for the purpose of transmitting power by electricity, together with the right, at all times to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines all trees and other like obstructions that may, in any way endanger the proper operation of the same.

The above right of way is for a line as shown by survey made by C.R. Claywell, on or about October 1923, and shown by stakes placed on the premises.

That it is hereby agreed between the parties hereto that the Power Company shall pay all actual damages to the crops of said Owners, their heirs, assigns or successors in title occasioned by the construction or repairing of the transmission lines, provided that said Owners presents a written claim therefor within sixty days after the act causing such damages.
