And it is further stipulated and unde-retood by the parties to these presents that at the end of this Lease the party of the second part shall have the right to purchase the above letten premises upon such terms and conditions as the parties hereunto shall agree upon, if the property be then for sale. Otherwise, upon one month's written notice by the party of the second part, he shall have the right to re-lease the said property upon the same terms and conditions as herein set forth for an additional term of two years.
