release, unto the said W.E. Rush, All our individual or collective right, title or interest in
and to all that certain piece, parcel or lot of land, situate, lying and being in the County of
Greenville and State of South Carolina;

Beginning at a corner of lot No. 1, said corner being 232 feet N. 30.30 E. from Birnie Street, said corner being also a corner of alley, according to a plat recorded in the office of the R.M.C. for Greenville County in Plat Book "A" at page 547, running thence along line of lots No. 1, 2 and 3 according to said plat, S.  $42-\frac{1}{2}$  E. 165 feet to corner lot No. 4; thence N. 30.30 E. about fifteen feet to the Right-of-way of the Southern Railway Company; thence with said Right-of-way N.  $42-\frac{1}{2}$  W. 165 feet; thence S. 30.30 W. about fifteen feet to the point of beginning.
