in case ont of my said children should have pre-deceased the other leaving issue it is intended in this instrument that the child or children of any of my said children who are beneficiaries under this trust shall represent their parent and shall take per stirpes his or her parant's share. The said Two Hundrad Ten Thousand and no/100 (\$210,000.00) Dollars with any accumulation that may not have been paid out is to be paid out when finally distributed, as follows:-

Forty-thousand & no/100 (\$40,000.00) Dollars being in trust for Aileen McGee, Forty thousand & no/100 (\$40,000.00) Dollars being in trust for May 4cGee Bull, Forty thousand & no/100 (\$40,000.00) Dollars being in trust for Marguerite G. McGee, and Forty thousand & no/100 (\$40,000.00) Dollars being in trust for Frederika P. AcGee, Twenty-five thousand & no/100 (\$25,000.00) Dollars being trust for James Henry McGee, and Twenty-five thousand & no/100 (\$25,000.00) Dollars being in trust for B.W. McGee, Jr.

This instrument has been made appointing the said H.P. McGee and C.A. McGee, Trustees until I shall select some good Trust Company that is satisfactory to me to take permanent charge of this fund with the end that said Trust Company may hold the same for the same uses and purposes herein expressed, and the said H.P. McGee and C.M. McGee will transfer hereafter to any Trust Company that I may select the said funds.

In the event the income from the fund shall not be sufficient to comfortably maintain any of the beneficiaries, then the Trustees, may in their descretion advance and pay out of the corpus of such fund a sufficient amount for his or her comfortable support and maintenance, charging the same against the part of said fund of such beneficiary.
