(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Mrs. M. W. Clatworthy, All of two certain tracts of land, to-wit: No. 1, containing forty six (46) acres, more or less, situated in Dunklin township, Greenville County, State aforesaid, and bounded by Chas. W. Stokes, Wm. J. Whitt, and by a tract described herein below.

Being the same tract conveyed by John W. McCallough to Josiah Whitt, Aug. 26-1885. And conveyed by the heirs at law of said Josiah Whitt, now deceased, to-wit: Mrs. Martha C. Whitt, Joe P. Whitt, Chas. E. Whitt, Geo. N. Whitt, et al. to John R. Whitt, Dec. 21-1915 and by said John R. Whitt to the said Geo. N. Whitt, Feby. 8, 1919. Which said deed is on record.

Containing five and one-half (5 1/2) acres, more or less, adjoining the above described tract, lying just south of the above, and on Mountain Creek, waters of Saluda river.

Thence, along the road, a foot 18.16 to a corner in the creek under the bridge. Thence S. 55 1/4 W. 2.45 stake 3, x, new. Bounded by the Cooley Whitt tract which is this day conveyed by Mrs. Mary Roxie Whitt to the said Mrs. M. W. Clatworthy. Thence N. 7 1/2 W. 6.07 Hickory stump 3, x, old. Bounded by Lafayette Cooley. Thence N. 87 1/2 E. 12.75 stone, 3, x, old. Thence N. 26 W. 3.52 stone 3, x, old. Thence N. 14 3/4 E. 16.67 stone 3, x, old. Thence N. 40 3/4 E. 9.69 stone 3, x, old.
