*E. H. Henley, her heirs and assigns,  
All that certain lot or parcel of land situate lying  
and being in Greenville County, State of  
South Carolina, near the City of Greenville on the Western side  
of Grandview Avenue and being better known and design-  
ated as lot No. 27 of Park Hill, a subdivision of Map No.  
1000, 1913, and having according to said plat the follow-  
ing metes and bounds, to-wit:  
Beginning at a stake on the Western side of Grandview  
Avenue, the West corner of lot No. 28 and 29 and  
running thence with said Avenue N. 27.10 E. 70 feet to  
a stake across lot No. 26; thence with line of  
lot No. 26 S. 62.50 W. 150 feet to stake, corner of lot No. 29;  
thence with line of that lot S. 27.10 W. 70 feet to a stake  
corner of lot No. 28; thence with line of that lot S.  
62.50 E. 150 feet to the point of beginning.*

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or  
appertaining.  
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

*E. H. Henley, his*  
heirs and assigns, forever.

Nevertheless upon the following conditions, which conditions are part of  
the consideration for this deed and are expressly for the benefit of all owners  
of lots as shown on plat above referred to, to-wit: (1) No building shall be erected nearer  
to the abutting sidewalk than thirty five feet nor shall any dwelling be e-  
rected upon said lot costing less than four thousand dollars (2) The property here-  
in conveyed shall never be sold, rented, or otherwise disposed of to a person,  
or persons, having any percentage of negro blood. (3) The property herein conveyed  
shall never be used for other than residential purposes and no building thereon  
shall ever be erected upon said lot which shall cost less than four thousand dollars.

AND *myself and my* do hereby bind  
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said  
*E. H. Henley, his*  
*myself* heirs and assigns, against  
*my* and  
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
