Will Lee, John Blasengame and Charlie Smith, as Trustees of Mountain View Church their successors and assigns forever: All that certain lot of land situate, lying and being in the City of Greenville, County and State aforesaid, on the corner of Mauldin street and Eagle street and having the following metes and bounds, to-wit:

Beginning at the Northeast corner of lot no. 12 and running thence S. 66-45 N. along and with said Mauldin street 79.7 feet to a stake: thence S. 42-57 E. along and with the line of lot no. 10 to a stake 32.4 feet from the line of lot no. 8: thence 75 feet to a stake on Eagle Street 32.4 feet from the intersection of the line of lot no. 8: thence N. 42-57 N. to the beginning corner and being known as a part of lot no. 12 of Block "B" of the Eagle-Mauldin property, as shown on a plat of the same recorded in the R.
