KNOW ALL MEN BY THESE PRESENTS, that *James F. Eppes* of *Greenville County*

in the State aforesaid, in consideration of the sum of *Five hundred* DOLLARS,

to *me* in hand paid at and before the sealing of these presents by *Rayford Williams*

the receipt whereof is hereby acknowledged, I have granted, bargained, sold, aliened, released, confirmed, quitclaimed, conveyed and confirmed unto the said *Rayford Williams* all that certain lot, piece, parcel or tract of land situated, lying and being in the State of South Carolina with County of Greenville, in the town of Mountain View, about three miles west of the city of Greenville, near Berea Church, having the following corners and courses according to a plat map of maps by W. L. Patterson, dated December 5, 1923, to wit: Beginning at an iron pin, S. 80° E. on the corner of land of said *Rayford Williams* 4.33 1/2 x 10.44 corners to an iron pin; thence S. 80° E. 4.85 chains to an iron pin; thence along line of *Mrs. Huff's* land N. 10° W. 3.00 chains to an iron pin; N. 77° E. 5.66 chains to an iron pin; thence along line of land still belonging to me N. 63° W. 17.20 chains to the beginning; corners containing six acres more or less. About three acres of said land is a part of five acre tract conveyed to me by *R. R. Eppes* by deed dated February 11, 1917 and recorded in the office of the Register of Deeds, Conveyance for said County which state in Book 36 at page 170. The other three acres is a part of the 5.57 acre tract conveyed to me by *Mrs. Martha J. Huff* by deed dated February 1, 1917 and recorded in said office in Book 36 at page 169. This land is covered by certain mortgages, but I undertake and guarantee to have it released from said mortgages.

AND *myself and my* do hereby bind heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Rayford Williams* and his heirs and assigns, against their, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
