(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said T. F. Simpson, his heirs and assigns forever: All those two certain pieces, parcels or lots of land situate about two miles from the corporate limits of the City of Greenville, in the County and State aforesaid, and known and designated as lots Nos. 1 and 2 as shown on a plat of the property of John Balogeras, said plat having been made by Walton & Neelce, Engineers June 27th, 1925, and bearing the following metes and bounds, according to said plat: Beginning at an iron pin at the intersection of Edwards Street with M^cBeth Street, and running thence along line of M^cBeth Street a distance of 169.5 feet to corner of lot Nos. 3; thence along line of lot Nos. 3, S. 46° 10' E. 118.3 feet to an iron pin on Edwards Street; thence along Edwards Street 194.5 feet to the beginning corner.

This conveyance is made subject to the following restrictions and reservations:

1. No building shall be erected nearer than thirty (30) feet to street line, so to cost less than Two Thousand Dollars (\$2000.00).
