NOW, therefore, Know all Men by these Presents, That I, *E. Inman* Master in and for the County of Greenville, aforesaid, in consideration of the sum of *Two hundred (\$200.00)* Dollars, to me paid by the said *Piedmont Livestock Company*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

Piedmont Livestock Company, its successors and assigns forever, the following described real estate:

"All that tract, piece or parcel of land situated in County of Greenville, State of South Carolina, and on the waters of South Piedlet River, adjoining the lands of J. J. Gosnell, Frances Kinsey and others, and being a part of the Levi Ward land, beginning at a poplar on said Ward's land (at a branch and running S. 68 E. 5 chs. to a pine; thence S. 43 E. 26 chs. to a pine; thence S. 10 E. 10 1/2 chs. to a red oak on Ward's line; thence with said Ward's line 60 W. 26 chs. to a chestnut oak; thence N. 45 W. 9 chs. to a forked red oak; thence N. 80 W. 32 chs. to a poplar on branch the beginning corner, and containing 60 acres more or less, and being the same conveyed to A. N. Hestrey by Margaret Holcomb, May Moore, Cora J. Jedy, et al, by deed recorded in Book 36, page 164, R. M. C. office for Greenville County"
