Culbertson, H. J. Boyd and others, commencing at a stone on the Georgia Road, W. C. Hammond's Chapel, and running thence N. 1/2 W. 1/2 to stone; thence N. 87 1/2 W. 1/2 to P. O.; thence S. 11 1/2 W. 1/2 to stone; thence S. 30 E. 1/2 to stone; thence S. 7 W. 1/2 to point on Georgia Road; thence along said road S. 7 1/2 W. to the beginning corner
