AND, WHEREAS, it is the desire of the parties hereto theorrest. the mistakes in said description, and to convey adequately and correctly the real estate intended to be conveyed. NOW, THEREFORE, THIS DEED WITNESSETH, That sor and in consideration of the premises, and in further consideration of one dollar in hand paid the said W.W. Stover, Jr., has given, granted bargained and sold, and doth by this instrument give, grant, bargain and sell, assign and convey unto the said Trustees all and bevery the following real estate lying and being situate in the City of Greenville, State of South Carolina, and being bounded and further described as follows:

PEGINNING at an iron pin on the East side of North Main Street fifty (50) feet south from the southeastern intersection of Main and Earle Streets, and running thence along said eastern line of North Main Street S. 19-39 W. fifty four and seven tenths (54.7) feet to an iron pin; thence S. 70-30 E. one hundred fifty five and five tenths (155.5) feet to an iron pin; thence N. 18-64 E. fifty two and five tenths (52.6) feet to an iron pin; thence N. 70-27 W. one hundred fifty five (155) and four tenths (165.4) feet to an iron pin on North Hain Street; this being the beginning corner.
