a corporation chartered under the laws of the United States and having one of its principal place of business at Greenville in the State of South Carolina for and in consideration of sum of Thirty five hundred (\$35,00.00) dollars to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mrs. Elizabeth Park Parker of the County of Greenville, State of South Carolina, her heirs, and assigns, forever:

All that certain, piece, parcel and lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, located in the subdivision known as Alta Vista, a plat of said subdivision being recorded in the R. M. C. office for Greenville County, South Carolina in Plat Book "G", at page 20, and the land herein deeded being shown on said plat and designated thereon as lot number thirty-nine (39) and being more particularly described as follows: to wit: Beginning at the corner of lot number 38 on Fairview Avenue and running thence S. 85-40 E. one hundred and seventy five (175) feet to lot number 51, thence along lines of lots numbers 50, 51 and 49 N. 4-15 E. 70 feet to lot number 40, thence along line of lot number forty N 85-40 E. one hundred and seventy five (175) feet to Fairview Avenue; thence along said Fairview Avenue S. 4-15 W. seventy (70) feet to the beginning porner.
