Know all men by these presents:

That we, W. T. Moyers and Henry D. Akin, both citizens of Potter County, Texas, and Thomas W. Castler of Fulton County, Georgia, under and by virtue of the laws of this State do hereby voluntarily associate ourselves together for the purpose of forming a private corporation under the terms and conditions hereinafter set out as follows:

1. The name of this corporation is "Interstate Mortgage Company".
2. The purpose for which it is formed is to erect or repair any building or improvement, and to accumulate and lend money for said purposes, and to purchase, sell and subdivide real property in towns, cities and villages and their suburbs not extending more than two miles beyond their limits and to accumulate and lend money for that purpose.
3. The place where the business of the corporation is to be transacted in Amarillo, Potter County, Texas.
4. The term for which it is to exist is fifty (50) years.
5. The number of directors shall be five (5) and the names and residences of those who are appointees for the first year are as follows:

6. The amount of capital stock is Seventy Five Thousand (\$75,000.00) Dollars, divided into three thousand (3,000) shares of \$25.00 each, all of which capital stock has been subscribed and paid in as shown by affidavit attached hereto.
