Lease of Petroleum Vending Privileges. (dental Determined by Sales)

They presented, made this 18thday of Juneary, in the year 1931, by and between D. M. Vaughnyon to them. hereinafter called Lessor and Standard Oil Company of New Jersey, hereinafter called Lessoe.

Witnesseth: Lesser dees hereby demise and lease unto Lessee the exclusive right to stere and sell gaseline, meter fuels, grease and other petroleum products, all of which are hereinafter referred to collectively as Petroleum Products, except Standard Meter Cits Lesses delivers for Mutual Petroleum Co.'s account during the year 1931, on the premises in the Town of MGreer; RFD (Nov.41. County of Greenwille, State of South Caroline,

One lot of land situated in the above County and State, beginning at the store of D. M. Vaughn extending 25 feet north to Sandy Flat Road, thence 40 feet east on Sandy Flat Road, thence 25 feet south, thence 40 feet west back to beginning point.

Lesses shall have the exclusive right and privilege of maintaining and using pumps, tanks and other facilities for the storage, sale and delivery of petroleum products and the servicing of automobiles at the places on said premises where pumps, tanks and other facilities are new located on said promises. Lessesshall also have the exclusive use and occupancy of an effice and storage space 10 feet long and 10 feet wide, located at the frant of the building on the premises herein described. Lesses shall also have the exclusive use and pessession of the machinery, teels, furniture and appliances which are listed in the schedule herete attached and marked Schedule A, Lesses, its employees, agents, customers and these having business with it sahll have full, free and unrestricted ingress, to egress from and access to and use of all of the space and facilities hereby leased to Lesses.

To held the promises hereby demised unto Lessee for the period of one years beginning on the 18 day of May. 1931, and ending on the 17thay of May or 1932, Lessee paying therefor as rental each menth an amount equivalent to one cent for each gallen of gaseline and ether meter fuels seld during the menth at said promises by Lessee, its agents or assigns. Payments of said rental are to be made on or before the tenth day of the menth following the menth in which the rental is earned. Lessee shall keep such beeks and records as will accurately show the number of gallens of gaseline and other meter fuels sold at the demised premises and will permit lesser to examine and inspect such beeks and records at any time and from time to time when lesser desires se to de.

1. Lesser will not store or sell or pormit anyone other than lessee and its employees, agents or assigns to store or sell any potroleum products of any kind whatseever at the premises herein described or in the streets adjacent therete.

- 2. Lessee shall pay the specified ront at the times and in the manner previded.
- 5. Lesser agrees to pay all taxes and assessments now or hereafter levied against said promises. Should Lesser failte pay such taxes or assessments when due and payable, Lesses shall have the right to pay the same and may withheld from any rentals payable hereunder as they accrue, such assumts as may be necessary to fully reinburse Lesses.
- 4. Lessee may install, move and remove at and from the premises hereby leased to 10 such tanks, pipes, pumps, equipment, machinery and other facilities for the storing, handling, and solling of petroleum products, and servicing authomobiles as shall in its epinion be necessary in order to use said premises for its business of storing, handling and solling of petroleum products. Lessee may paint the tanks, pumps, machinery and other equipment installed or operated by it, and may paint the buildings on the premises herein described in any colors it shall elect, and to paint thereon any of its trade marks and other signs, devices and advertisements.
- 5. Upon the expiration or termination of this lease for any cause, Lessee is to return the property described in Schodule A, herete attached to Lesser and Lessee shall restore said premises to the condition existing on the date hereof, ordinary wear and tear excepted. Lessee shall have the right to remove from said premises all tanks, pumps, pipes, equipment, machinery and other facilities placed thereon by Lessee.
- 6. In ease the premises are rendered unfit for eccupancy by fire, sterm, explosion or any other cause, no rental shall accrue or is to be paid from the beginning of such unfitness for eccupancy until the premises are put in tenantable condition and Lossoo is able to and does eccupy said premises for thepurposes herein described.
- 7. Lessee during the term of this lease or any remeval or extension thereof shall have the right and privilege to sublet or assign all or any part of its right under and to said premises, but any such subletting or assignment shall not relieve Lessee from its obligation to pay the rent herein reserved unless Lesser shall consent in writing to such subletting or assignment.
