Know all men by these presents, That I, Lewis Barber, (unmarried) of the City of New York, in the State of New York, for and in consideration of the sum of Five Hundred Dollars in hand paid to me by Central Agencies Company, of the City of Greenville, in the State of South Carolina; the assumption by them of the taxes and assessments, assessed or assessable upon the premises hereinafter described for the year 1931, and all installments of assessments, whensoever assessed, that shall become due and payable subsequent to the date hereof; and other good and valuable consideration, being assumption of mortgage of \$3,000.00, the receipt of all of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release, unto the said Central Agencies Company.

All that certain piece, parcel or lot of land situate, lying and being in Ward One of the City of Greenville, State and County aforeside, on the West side of Robinson Street, and having, according to a survey made by Dalton & Neves, Engineers, May 1928, the following metes and bounds, to wit:
