M. Thompson, thence with Thompson line N. 1° 41' 0" E. 20.8 feet to stake; thence S. 85° 39' W. 54.4 feet to corner of lot no. 243, thence with line of lot no. 243 S. 1° 41' 0" E. 20.8 feet to the beginning corner.
