Office for Greenville County in Plat Book C, page 63, and having the following notes and bounds, to-wit:

Beginning at an iron pin on the South side of Parker Road, corner of lot No. 17, and running thence along line of Lot No. 17 in a southerly direction 167 feet to an iron pin; thence N. 89° E. 50 feet to an iron pin, corner of lot No. 19; thence with line of Lot No. 19, 163 feet to an iron pin on Parker Road; thence with said Road S. 81° E. 50 feet to the beginning corner. This being the same lot of land conveyed to the Grantor by W.D. Workman. There is situate on this lot a dwelling house and store room combined.
