(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Flourance Nightingale League. All that certain lot or parcel of land situate lying and being in the Parish of St. Andrew's, Greenville County, South Carolina, being with known and designated as lot no. 23 of a subdivision known as "Parkway" consisting of lots made by the Board of Commissioners of the County of Greenville, South Carolina, in 1916 and having according to said plat two corners with lot no. 24 and lot no. 22.

Commencing at a stake on the north side of Forest Avenue 75 feet west of Buist Avenue and having Street extension and running north-south from Forest Avenue N. 79-45 N. 100 feet to corner of lot no. 21, thence with line of lot no. 21 N. 11-55 E. 170 feet to an alley known as Alley B 79-45 N. 100 feet to corner of lot no. 23, thence with line of lot no. 23 N. 11-55 E. 170 feet to Buist Avenue the beginning corner being the same lot of land conveyed to E. Rust by E. Inman, Master by deed dated December 9th, 1925 and recorded in the Public Office for Greenville County in Vol. 110 of Book 160 and being conveyed to me by E. Rust by deed dated Jan. 29th, 1926, and recorded in volume 106 page 390.

The grantee by accepting this deed assumes and agrees to pay a certain mortgage over the above described premises executed by the grantor to the Prudential Insurance Company of America in the sum of thirty-two hundred (\$3200.00) Dollars, said mortgage being of record in the Public Office for Greenville County in mortgage book 141 page 23.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
