*W. P. Gibson* in and to certain piece parcel and lot of land situated in the State of South Carolina and County of Greenville known as the *W. P. Gibson* tract near the town of *Green* on the North East side of the *North Carolina* road adjoining lands of *W. P. Gibson* and being a part of two tracts of land conveyed to me, the said *W. P. Gibson* and *W. P. Gibson* by deed bearing date *Nov. 27th 1920* and included in the index of *R. M. C. for Greenville County* No. *17* at page *2* and the said tract was conveyed to the said *W. P. Gibson* in and to the said *W. P. Gibson* bearing date of *Feb. 12th 1921* and included in the index of *R. M. C. for Greenville County* No. *17* at page *3*, and having the following metes and bounds *beginning on an iron pin in the intersection of the North Carolina road and the road leading to the new slaughter pen and thence with the slaughter pen road N. 72-45-6-47-2 feet to a stake in the center of the said road, (and this pin on North bank of road) and thence on the road) thence N. 1-15 W. 437 feet to a stake on the present line of *W. P. Gibson* thence N. 7-65 W. 226 feet to an iron pin, John Suttles house thence with the Suttles line S. 48-38 W. 499 feet to an iron pin in the center of the *North Carolina* Road, thence with the said Road S. 35-38-67 feet to a bend in the said Road thence S. 24-01-6-212 feet to the beginning corner containing five and thirty five one hundredths (5-35) acres more or less*
