All that certain piece, parcel and tract of land containing 18.47 acres, more or less, acreage, lying and being in the County and State aforesaid, in Greenville Township, comprising those four lots known and designated as Lots Nos. 62, 23, 24 and 25 as shown on a plat of land owned by the Realty Corporation, said plat being recorded in the R.M.C. Office for Greenville County, in Plat Book E, Page 272, and being more particularly described as follows:
Beginning at a point on Augusta Road and running thence N. 67-07 E. 1343.5 feet to an alley, thence S. 23-00 E. 596.6 feet to a stake, thence S. 64-49 E. 1283.5 feet to a stake on said Augusta Road, thence with said Augusta Road N. 28-25 E. 649.5 feet to the beginning point. This being the same tract of land conveyed to me by the Realty Corporation, August 4th 1925, by deed recorded in the R.M.C. Office for Greenville County, in Vol. 72, Page 383.

Also, all that certain tract or parcel of land aforesaid, lying and being near the City of Greenville, County and State aforesaid, and containing 14.72 acres, according to plat made by R.E. Dalton, Aug. 26, 1926, and having the following number and boundaries to wit: Beginning at an iron pipe in the center of Augusta Road at corner of Traxler Park, and running thence with said Traxler Park N. 64-05 E. 1283.5 feet to iron pipe, west side of a proposed road; thence with the western side of said proposed road, S. 23-44 E. 511.5 feet to an iron pipe, corner of Pink James property line, with Pink James' line, S. 64-50 E. 115.5 feet to a stone in the center of said Augusta Road, S. 46-44 E. 100 feet to point in center of said road, S. 46-44 E. 100 feet to the center of said road N. 37-50 E. 200 feet to point in center of said road; thence still with the center of said road N. 27-50 E. 198 feet to an iron pipe, the beginning of the tract of land aforesaid to be sold by the Realty Corporation August 26th 1925, for 1st mortgage held in the R.M.C. Office for Greenville County, Vol. 72, Page 120.
