that certain lot of land situate lying and

State of South Carolina and having the following
meters and bounds, to-wit;
Beginning at a stake on the north side of
John Street, 109 1/4 feet from the northwest corner
of John and Boyd Streets and running thence
northward and parallel with Boyd Street 147 feet
to a stake whence westward and parallel
with John Street 30 feet to a stake; thence
northward and parallel with Boyd Street 30 feet
to a stake on S. Monroe Pickens line, thence
westward along his line 30 feet to a stake
on Bellinger's line, thence backward along
Bellinger's line 147 feet to a stake on the
north side of John Street; thence eastward along
said street 60 feet to the beginning corner and
