(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

M. J. Bates, all that piece parcel and tract of land lying situated and being in Bates Township State and County aforesaid known as a part of the land conveyed to me by deed from James W. Humphreys, adjoining lands of myself and J. S. Epps etale and others.

Beginning on an iron pin S.E. corner thence running N. 82 1/2 W. 13.00 to the Pickens Road thence with said road N. 25 1/2 E. 4.50 to a bend thence N. 42 E. 7.00 to a bend thence N. 72 E. 2.05 to iron pin, thence S. 85 1/2 E. 7.00 to iron pin in Old Road, thence S. 6 W. 12.50 to the beginning corner and contains 12 1/2 acres more or less, I hereby except a Rightway through the above described land where the Road now is.
