KNOW ALL MEN BY THESE PRESENTS, That I, C.F. Putman

In the State aforesaid, in consideration of the sum of Ten DOLLARS, and other valuable considerations to me in hand paid at and before the sealing of these presents by S.E. Sontell

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said S.E. Sontell, his heirs and assigns, All that certain lot of land in the County of Greenville, near the City of Greenville, in a subdivision known as "Fair Heights", having the following metes and bounds: Beginning at an iron pin 202.6 feet from the Southeast corner of Laurens Road and Brookdale Avenue and running thence N. 33-0 E. 147.8 feet to an iron pin; thence S. 1-55 E. 31 feet to an iron pin; thence E. 59-40 W. 150 feet to Brookdale Avenue; thence with Brookdale Avenue E. 31-20 E. 90 feet to the beginning corner, being designated as lot No. 6 of Block D. on a plat of "Fair Heights" property which plat is recorded in the office of R.M.C. for Greenville County in Plat Book "P" at page 257, and being the same tract of land conveyed to C.F. Putman by Forwood National Bank, by deed dated May 28th, 1928, and recorded in Volume 116, at page 121.

Also all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, known and designated as lot #90 of the subdivision known as "Augusta Circle", as shown on a plat of record in the R.M.C. for Greenville County, South Carolina, in Plat Book "P", at page #23, and having the following metes and bounds, to-wit: Beginning at an iron pin on the Eastern side of Paris Road, joint corner of lots Nos. 98 and 99, and running thence with the joint lines of said lots S. 71-35 E. 160.7 feet to an iron pin, joint corner of lots Nos. 84, 85, 98 and 99; thence with the joint lines of 84 and 99, S. 21-36 W. fifty feet to an iron pin, the joint corners of lots Nos. 83, 84, 99 and 100; thence with the joint lines of lots 99 and 100, N. 71-35 W. 156.3 feet to an iron pin on Paris Road; thence with the eastern side of Paris Road N. 16-30 E. 49-86 feet to the beginning point, and being the same tract of land conveyed to me by W.A. Chandler by his deed dated March 12th, 1926, and recorded in Volume 104, at page 15.

Also all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville on the north side of Easley Bridge Road, having the following metes and bounds according to a plat of Highland, made by H.D. Neaves, Engineer, and recorded in the R.M.C. Office for Greenville County in Plat Book "C" at page 146: Beginning at an iron pin on north side of Easley Bridge Road, corner of lot No. 6, and running thence N. 15-10 W. 127.7 feet to iron pin on ten foot alley; thence along ten foot alley, S. 73 W. 65 feet to iron pin on Carolina Avenue; thence along Carolina Avenue, S. 15-10 E. 129.8 feet to iron pin on north side of Easley Bridge Road; thence along north side of Easley Bridge Road, N. 73 E. 65.1 feet to the beginning corner, being known and designated as lot No. 6 on said plat. This deed is executed subject to the restrictions and conditions contained in deed from Sallie Hart Harris, Atty. to C.L. Peole, and being the same tract of land conveyed to me by Lilly May White, by her deed dated May 18th, 1925 and recorded in the R.M.C. Office for Greenville County in Volume 104, at page 66. The Grantee herein agrees to assume and pay a note and mortgage given by C.F. Putman to the American Building & Loan Co., in the sum of \$1,644.75.

Also all that certain parcel and lot of land situate and being in the State and County, Greenville Township, Beginning at an iron pin on the South side of Parker Road corner of Lot No. 17; thence along the line of lot No. 17 in a southerly direction one hundred sixty-seven (167) feet to iron pin; thence N. 83-1/2 W. Fifty (50) feet to iron pin, corner of lot No. 19; thence along line of lot No. 19, one hundred and sixty eight feet (168) to an iron pin on Parker Road; thence with the said road S. 81-1/2 E. Fifty (50) feet to the beginning corner, and being the same land conveyed to me by C.P. Simmons and James Graham by their deed dated 27th, Nov. 1925 and recorded in the R.M.C. Office for Greenville County in Volume 117, page 59.

The grantee is to pay the taxes on the above described property for the year of 1928.

AND myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

S.E. Sontell, his heirs and assigns, against and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
